NEGATIVE RT-PCR EXAM REQUIREMENT TO ENTER BRAZIL

On November 27, a statement from the Brazilian Federal Government was issued stating that travelers, both foreign and Brazilian, must submit a non-detectable (negative) RT-PCR test, collected in the last 72 hours before boarding, or a negative test of the type antigen, collected within 24 hours of departure. In addition, it is required to complete the Traveler's Health Declaration (DSV) within 24 hours prior to departure to Brazil, available on the website of the National Health Surveillance Agency (ANVISA).
